(Quality, Environmental Protection, Health and Safety)

Corporate Guidelines

- Our actions regarding customer satisfaction are organized in view of our product's entire life cycle. This comprises development-, offer- and order-processes as well as "after sales service". We rely on cooperation and partnership with our customers, suppliers and other interested parties based on mutual trust.
- We are one of the world's leading and most innovative companies in the area of cables, wires, flexible cables and related accessories and play a substantial role in determining technological progress.
- We develop, manufacture and sell environmentally acceptable and safe products of a very high quality.
- Our innovation is the basis for achieving positive contributions to the value of our company and enables us to justify the trust of our customers and our lenders in the present as well as the future.
- Our company's success is based on our employees' creativity and will to achieve. Measures to enable them to gain further qualification and training empower them to fulfil their responsibilities in all work areas in accordance with the latest technological developments.
- Protection of the environment, the health of our employees as well as competitiveness and earning power in our company are ensured by the existing process and product competence. To this end, target programmes are drafted, implemented and monitored on an ongoing basis.
- We regard the observation of existing laws, national and international rules, standards and regulations as a minimum requirement.
- We apply an effective, integrated management system in compliance with the standards set by Sector. It fulfils the requirements of the current ISO 9001, ISO 14001 and OHSAS 18001 standards and is certified.
- We make sure that responsibilities are accurately defined and are entrusted to people possessing the necessary competence and corresponding authority.
- Our processes are clearly defined. They are planned, monitored, assessed regularly and continually improved. Documented controls help ensure and communicate the execution of all the essential actions required for this purpose.
- We conclude agreements for quality assurance measures with our suppliers and service providers cooperate on environmental aspects and exercise a joint influence on occupational safety.
- The annual agreement concerning target programmes (quality, environmental and health and safety targets) ensues in the form of a cascade of targets. The employees are involved in this process, for which the necessary resources are provided.
- We compile annual reports showing the results of the target programmes and all activities affecting behaviour relating to the environment and occupational safety.
- Management reviews evaluate in turn the status, the suitability and the efficacy of the integrated management system.
- The present management policy is made publicly available and distribute to all employees.

Action Principles “Quality”

- The high quality and safety of our products and services are the result of optimised process design in all areas and of cooperation with our customers and suppliers.
- We reassess these processes regularly using key figures as a basis, and deduce from them the potential for improvement.
- We monitor process quality by means of regular audits in order to achieve a continuous improvement of our quality management system.
- We make every effort to ensure that the name “**PRYSMIAN**” stands for quality, reliability and trust.

Action Principles “Environmental protection”


- We assess the environmental impact of our processes, machines, facilities and products adopting a “full life cycle”. To this end we promote environmentally oriented product development in compliance with international standards and take environmental aspects into account when making investment decisions, purchases, and sales or when shutting down a facility.
- We monitor and analyse the most significant environmental aspects in normal and emergency conditions and ensure that our locations harmonise with the surrounding infrastructure.
- We advise and support our customers with regard to the environmentally compatible use of our products as well as their environmentally compatible disposal. Environmental information is communicated both internally and externally.
- On the waste management side we act according to the principle: “Avoidance in preference to recycling” and “Recycling in preference to environmentally compatible disposal”.
- In order to protect resources we minimise the consumption of materials, energy and water as well as waste and the emission of hazardous substances on land, in the air and in water.

Action Principles “Occupational Safety”

- We respect the protection of the integrity, health and welfare of our employees at the workplace as being basic needs.
- We feel obligated to introduce preventive measures to avoid accidents and work-related diseases, and thus to minimise any impairment to the safety and health of all employees and third parties as well as improving safety and health protection.
- On-the-job safety is for us a part and parcel of good work. We therefore establish and promote a sense of responsibility at all levels and obligate our employees to act consciously and safely at all times.
- We plan and monitor the working environment and processes as well as the way they change, taking into account ergonomics, occupational safety and health protection.
- We assess the risk of occupational accidents and job-related diseases evaluate accident trends and exercise influence on the sources of risk, taking into account the status of technology, occupational medicine and hygiene.
